- 1) Roll Call. Notes:

 - b) The 3rd Iowa Artillery, Unit Commander Roger Shannon with other members came to Boscobel as observers last year, and are considering joining next year. They are from the Des Moines, Iowa area.
- The minutes of the February 10 & 16 2013, Annual Meeting were approved without reading after Gary Van Kauwenbergh stated he'd review them and included all the outstanding action items in our agenda.
- 3) Paymaster report.
 - a) There is no separate WI/IL Regional treasury. With no significant financial transactions looming, the group decided to not establish separate dues or a checking account for the WI/IL region. Balance at beginning of year - \$3,060.03. Balance on hand in the ACWSA checking account as of 8/30/13 - \$2,764.70. Budgeted balance was expected to be \$3,287. Expenses outside of budget included a promotional video (\$300) and ACWSA signage (\$208.80).
 - b) All financial activity for Bristol storage shed is now complete. The total cost of the shed was \$1803.12, of which \$1,425.00 in membership assessments went into and came out of the national checking account. An additional \$378.12 was generated through a raffle and contributions from the teams actually using the shed. The additional \$378.12 was handled on a cash basis between the parties concerned and outside of the checkbook.

4) Old Business.
