A large acorn is approximately the same surface area of a metal tile target, and the small acorn is about the size of the metal rectangles. Cost quoted was \$ 500 for 240 large. The small targets we would get more yield due to the size using the same amount of steel, but would cost more also. Discussion followed. Mike was given authority to move forward with the purchase of the large acorn design.

The option of selling some of the existing target shapes to members was discussed since the Region has a surplus. No decision was made on this subject yet.
